NOTICE OF NOMINATION AND ELECTION – INSHORE DIVISION

Election of Officers and Executive Board Fish, Food and Allied Workers (FFAW-Unifor)

As per Article VII of the FFAW-Unifor Constitution, written notice is hereby given to all members in good standing of a pending nomination period and election period for the Officers and Executive Board.

The Election Committee was elected at the 2021 Constitutional Convention. This Committee is given the responsibility of conducting this election.

Completed nomination forms and a signed and sworn affidavit must be received **no later than 4:30 pm, Wednesday, May 22, 2024** at the following:

A second mailing will be sent to you in June containing a secret ballot on which to vote. At least 30 calendar days from the date of mailing shall be allowed for their return.

NOMINATION PROCEDURE

Inshore members can nominate candidates for the following:

1. President
2. Secretary-Treasurer
3. Inshore Vice-President

Executive Board Members for the geographic area/sector in which you work, as per the following:

4. One Executive Board Member to be elected by members of the Inshore Division on the Avalon Peninsula (Swift Current to Sunnyside);

5. One Executive Board Member to be elected by members of the Inshore Division on the Northeast Coast (Southport to Jackson's Arm);
6. One Executive Board Member to be elected by members of the Inshore Division on the Northern Peninsula and Labrador (Harbour Deep to Norris Point, plus Labrador);
7. One Executive Board Member to be elected by members of the Inshore Division on the West and South Coasts (Woody Point to Monkstown).
8. One Executive Board Member to be elected to the Women's position representing women members in the Inshore Division.
9. One Executive Board Member to be elected to represent Crew members in the Inshore Division.

Note: Nominators must be members of the constituency which the nominee seeks to represent.


The Inshore Women's and Crew member positions were established to ensure our inshore women and crew members are represented on our Executive Board. Only inshore women and crew members are eligible to nominate and run for these positions. The election of the Women's and Crew member positions will take place at the Constitutional Convention.

Note: the nomination period for all positions is May 1 to May 22, 2024.

RULES AND POLICY PROCEDURES

1. DRAFTING OF RULES AND PROCEDURES

The rules and procedures for the upcoming election shall be approved by the Executive Board.

2. ELECTION OFFICE

The Election Office: Chairperson – FFAW-Unifor Election Committee

3. ELECTION PROCESS

- Elections will be conducted by secret ballot.
- Ballots shall be mailed simultaneously to all members in good standing.
- All ballots mailed out shall be accompanied by a pre-paid return envelope.
- The voting period shall be no less than 30 days from the date that the ballots are mailed out.
- Ballots must be returned in the mail to the Election Office. **Ballots CANNOT be delivered in person to the Election office.**
- Only one ballot per postage-paid return envelope.
- Any ballots not properly returned or returned after the close of the voting period shall be declared spoiled.

4. WINNING CANDIDATE CRITERIA

For the election of President and Secretary-Treasurer of FFAW, the candidate who receives a simple majority of votes shall be declared the winner of the election.

For the election of Vice-President – Inshore, the candidate who receives a simple majority of the votes from the Inshore Division shall be declared the winner of the election.

For the election of Vice-President – Industrial/Retail/Offshore, the candidate who receives a simple majority of the votes from the Industrial/Retail/Offshore Division shall be declared the winner of the election.

For the election of all other Executive Board positions, with the exception of the Women's Representatives and the Crew Member positions, the winners shall be those candidates who receive a simple majority of the votes within the corresponding geographic areas or unit.

5. ELECTION CALL

The Union shall forward to each member in good standing an Election Call containing:

The time frame of the election for all positions on the Executive Board; and
Formal notification of the last day for nominations, the voting period, and the final date the Union will accept ballots.

The Union shall also note in its Election Call the last fixed date at which a member can confirm whether he or she is in good standing and on the voters' list.

6. NOMINATION PROCESS

All candidates running for a position on the Executive Board of the Union must meet the following nomination criteria:

- a. Be a member in good standing of FFAW-Unifor;
- b. Not accept a nomination for any other position with the Executive Board being voted upon;
- c. Forwarded and seconded by two members in good standing who are also members of the constituency that the nominee seeks to represent (e.g. All members in good standing can nominate the President but only members in good standing within the Avalon Peninsula can nominate someone for the Avalon seat of the Inshore Executive Board.);
- d. Be a resident of the geographic area for which the nomination is sought (e.g. A nominee for the Inshore Avalon seat on the Executive Board must normally reside within the Avalon Peninsula as described in Article 5, Section 3 of the FFAW-Unifor Constitution.);
- e. Submit the completed and properly sworn affidavit, a template of which is provided in Appendix 'A';
- f. Completed nomination papers and a properly sworn affidavit by the nominee, shall be submitted via fax, mail, E-mail, or in person to the Election Committee.

The nomination period is from May 1 to May 22, 2024. Nominations must be received by the Election Committee no later than 4:30 pm on May 22, 2024.

If only one person is nominated for a position on the Executive Board by the close of nominations, the Election Committee shall declare the sole nominee as duly elected by acclamation.

Should a nomination period for an Executive Board position close with no nominee, the nomination period shall be extended for an additional thirty (30) calendar days.

7. RIGHTS AND OBLIGATIONS OF CANDIDATES

Scrutineers

Only a candidate's designated scrutineer may observe the counting of ballots.

Election Conduct

Candidates and their supporters will be expected to observe accepted standards of conduct throughout the nomination and election period. No candidate or their supporters shall publish or circulate, either verbally or otherwise, information on another candidate that is false or defames that person's character and/or integrity.

Campaign Donations

Candidates shall not accept campaign donations from any corporations or an agent for a corporation or from an organization competing with FFAW in a manner that is detrimental to FFAW.

Volunteer work done on behalf of a candidate is not considered a campaign expenditure.

FFAW Facilities

Neither candidate for the office of President or Secretary-Treasurer, nor their supporters, may post campaign material at Union-owned facilities.

8. VOTERS' LIST AND ISSUING OF BALLOTS

The voters' list shall be finalized on May 21, 2024.

FFAW staff will carry out the initial Notice of Nomination and Election mail out under the direction of the Election Committee. Any questions or concerns brought forward to the office will be directed/discussed with the Election Committee.

9. RE-ISSUING LOST OR DESTROYED BALLOTS

A member who informs the Election Committee that they has either lost or did not receive a ballot, shall be issued another ballot on the following conditions:

- The Election Committee has a record of sending out a ballot to the member seeking a new ballot.
- The member submits the signed affidavit attesting to the lost ballot. A copy of the affidavit will be made available upon request.

The original ballot, along with its return envelope, which the member claims to be lost, destroyed, or never delivered, shall be considered null and void.

10. TIME FRAMES

The last day to return a ballot is July 19, 2024.

Ballots will be counted on July 24, 2024 under the supervision of the Election Committee.

All candidates will be advised immediately of the results of the election on completion of the counting of the ballots. The results of the election shall be reported to the membership through an official Union media release and through the Union's website within one (1) day of the results being finalized.

The ballots and all other records pertaining to nominations and elections, including the membership mailing list which was used to send the notices of the nominations and elections, shall be preserved for not less than one year by the Election Committee. At the end of the one-year period, the Election Committee may pass a motion to destroy the ballots.

In the event of a mail disruption at the time of the election, the Election Committee shall have the right to make decisions regarding time frames and alternate voting procedures.

11. CHALLENGES TO THE ELECTION

All challenges to an election by a candidate shall be submitted to the Chairperson of the Election Committee not more than fifteen (15) calendar days after the close of the election period. The election period concludes on the day the results are publicly declared by FFAW.

The Election Committee shall consider any such challenge and such remedial action as they deem appropriate within thirty (30) days of the challenge being filed. Irregularity in procedure shall not automatically invalidate an election.

Not more than fifteen (15) days after the decision of the Election Committee on the challenge, the aggrieved party may appeal the Election Committee's decision to the Executive Board. If the challenge relates to a sitting Union Officer or member of the Executive Board, that Executive Board member shall not attend or participate in any meetings or discussions related to the election challenge. The decision of the Executive Board is final.

12. SPOILED BALLOTS

A ballot shall be considered spoiled under the following circumstances:

- A candidate is written in for an election for which that candidate was not properly nominated;
- More than one candidate for a particular election is selected;
- A ballot is defaced in any way;

Each member must use the postage-paid envelope provided to them. The ballots of more than one member cannot be included in the same postage-paid envelope. Any ballot returned with one or more other ballots in the postage-paid envelope shall be deemed spoiled and shall not be counted.

TIME FRAMES FOR THE 2024 ELECTION OF THE FFAW-UNIFOR EXECUTIVE BOARD

PRE-VOTE PERIOD

Notice of election posted by the Union in local newspapers, social media, and in a press release on **April 29, 2024.**

Mail out of Election Forms and Election Rules and Procedures on **May 1, 2024.**

Last day to finalize the Voters' List and provide a copy to the Election Committee is **May 21, 2024.**

Last day to submit nomination papers is **May 22, 2024.**

Election Committee reviews nominations and finalizes the list of candidates on **May 27, 2024.**

BALLOT PERIOD

Ballots to be mailed out to members in good standing on **June 18, 2024.**

Last day for ballots to be received by the Election Office is **July 19, 2024.**

Ballots in the mail picked up on the morning of **July 24, 2024,** will also be included.

Ballots will be counted on **July 24, 2024**

Installation of the new Executive Board will be on **November 19, 2024.**
